Puppies for Parole

This past year the Adair County Humane Society has been fortunate to partner with the Missouri Department of Correction and their Puppies for Parole Program (P4P) at the Moberly Correctional Center.

This unique program allows carefully selected offenders the opportunity to become trainers to shelter dogs.

The program saves dogs lives in communities across our state. Many dogs that graduated from this program were dogs that may have been unadoptable otherwise.

Adair County Humane Society is fortunate that 18 of our 20 dogs that have graduated from the program have found their forever homes.

The offenders work with the dogs to teach them basic obedience and socialization skills. P4P gives the offenders the skills necessary to support successful rehabilitation and reentry.

The correctional centers benefit as well. This program has proven to boost staff and offender morale.

The Traveling Operating Room

During 2017, the Adair County Humane Society (ACHS) continued working with University of Missouri College of Veterinarian Medicine and their Shelter Medicine Program's mobile shelter medicine unit.

The University brings their "operating room on wheels" to the shelter grounds and performs spay and neuter surgeries. These services are provided to the ACHS

at a minimum cost for vehicle expense only.

Surgeries are performed by veterinary students under the direct supervision of a professor.

This program provides the students with valuable experience in animal surgeries and allows the shelter animals to go to their "forever" home the day they are adopted.

Each time the shelter has

a minimum of ten animals ready for surgery the big bus arrives. During 2017, 116 ACHS animals benefitted from the project. Thanks to the MIZZOU Vet School and everyone involved in this great program.

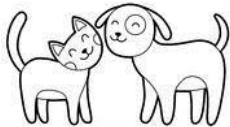




Joyful Celebrations 2017

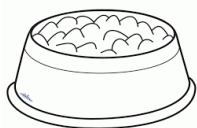
103 puppies & dogs and 58 kittens & cats were placed in adoptive homes.

shared concern that should drive everything the shelter does.

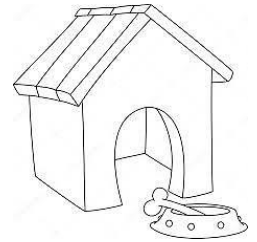

Looking at the Financials

Thanks to everyone who has made this shelter the wonderful place it is. Financials are an important part of our organization especially as we look to the future. With your continued support we can continue the legacy left to us by those who came before.

Our income depends on our members and on our community. Donations, memorials, membership dues, gifts, and the donation banks placed around town, contribute

about half of our income. Our contract with the City of Kirksville provides about forty percent and adoptions fees and a few miscellaneous items make up the rest.

As with most organizations, payroll makes up the largest part of our expenses. This is followed by building utilities, maintenance, and supplies. Other expenses include veterinarian care, pet supplies, insurance, and several smaller items.

It is interesting to note that money spent for the actual care of the animals is a small part of our finances. Perhaps this is possible due to donations of veterinarian services, food, pet supplies, and the countless hours donated by volunteers to socialize our animals. We thank everyone for their support.

The Adair County Humane Society is a not-for-profit (gifts are tax deductible) organization funded by donations from the citizens of Kirksville and the surrounding area. It is not affiliated with nor does it receive funds from any county, state or national organization. The Adair County Humane Shelter is operated under the certification of the Missouri Department of Agriculture.

ABOUT the Adair County Humane Society

Our mission is to provide a nurturing and safe environment for the homeless, abandoned and neglected animals in the Adair County area. We are a privately run 501 (c)(3) non-profit organization. Donations are welcome and tax-deductible.

Adoption Fees

Adult Cats: \$115 and up	Kittens: \$40 (\$40 sterilization deposit)
Adult Dogs: \$120 and up	Puppies: \$40 (\$40 sterilization deposit)

The sterilization deposit is paid upon adoption and returned once proof of sterilization is presented.

Volunteering - We happily accept offers to volunteer at the shelter. All volunteers must attend an orientation. Volunteering hours are 12 PM - 4 PM on weekdays.

City and County Agreements

During 2017, the City of Kirksville and the ACHS continued with their agreement to care for animals confiscated by the city. This contract, to care for and house animals brought in by the City Animal Control Officer, provides a portion of the ACHS income. During 2017, 116 dogs and 182 cats were brought to the shelter by the city. The ACHS greatly appreciates the cooperation and support of the City of Kirksville.

During December 2017, the ACHS and a representative from the Adair County Commission met to begin negotiating an agreement between the two parties to care for animals the county gains possession of. A mutually accepted agreement is expected to be reached in early 2018.

Membership

The ACHS could not exist without the support of our members. Thank you. Take a minute to look at the newsletter address label.
